The Mandal Educational Officer, Jammikunta has submitted proposals submitted by the Correspondent **SRI KAKATIYA Primary School Nursery-Vth EM,HNO 6-2-72/1,2,3,4, JAMMIKUNTA,Jammikunta** for Grant of Extension of Temporary Recognition for the classes **(Nuresey to V) EM** as per the conditions 1st cited.

After carefully examination proposals and the conditions prescribed in G.O. Ms. No. 1 Education Dt.01-01-1994. The District Educational Officer, Karimnagar is pleased to accord **Extension of Temporary Recognition** for the period commencing from the academic year **2020-2021 to 2024-2025** for classes **(Nuresey to V) EM with adl section B,C & D Only to SRI KAKATIYA Primary School Nursery-Vth EM,HNO 6-2-72/1,2,3,4, JAMMIKUNTA,Jammikunta** subject to the fulfillment of the following conditions.

1. That the society abides by the instructions/rules and regulations made by the Government of authorized officer from time to time.
2. That the Educational Institution shall serve the needs of the locality more particularly.
3. That the institution shall adopt the curriculum and syllabus prescribed from time to time.
4. The School timing, Vocational and mid-term Holidays shall be followed pre-scribed by the Government from time to time.
5. As per the staffing pattern the qualified staff within the age limits prescribed by the Government for Government Employees shall be appointed.
6. Appointment of Teaching and Non-Teaching Staff within the age limits prescribed by the Government for Government Employees shall be appointed.
7. That the results of Institutions shall be satisfactory every year.
8. That the records/accounts shall be furnished to the District Educational Officer every year by 30th September at the latest.
9. That the governing body/Staff selection committee shall be furnished to the District Educational Officer every year.
10. The approval of the correspondent ship should be get approved by the competent authority.
11. That the pay structure/fee structure fixed by the governing body shall be get approved by the District Educational Officer every year.
12. That the school shall not be closed without giving prior notice both to the parents/District Educational Officer and to the competent authority concerned at least 6 months before.
13. That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
14. That the society shall submit proposal for renewal of provisional recognition will in advance i.e. at least 6 months prior to the date of expiry of the renewal.
15. Next higher classes additional sections should not be opened with-out prior permission from the competent authority.
16. Sufficient Play grounds, Library Books, Laboratory equipment shall be provided as per rules.
17. Provide suggestion boxes in prominent place in the school premises.
18. Compulsorily provide the extinguishers and fire fighting equipments as prescribed in the National Building Code of India part IV fire protection 1997 and provide by fire service department of the state.
19. Maintain first Aid Kits in sufficient numbers in the school premises.
20. Follow the rules and regulations prescribed in Cir. Memo No. 21748/D1/97 Dt. 16-2-1998 and other orders of Transport Authority regarding parking of school Vehicles/maintenance of vehicles and ensure safety of children and shall obtain fitness of the school vehicles from the transport authorities as prescribed by the Government from time to time.
21. The cost of providing Zebra crossing at the roads crossing near the schools which are located in Municipal Corporation/Town shall be met by the school management.
22. Have adequate personnel to guide the movement of the children to ensure road safety and transportation.
23. The management should follow the text books and syllabus prescribed other than the syllabus text books, prescribed by the Government should be used.
24. The Hindi Subject should be taught for the students of VI Class and higher classes.
25. That all Condition prescribed in G.O.Ms.No. 1 Dt. 1-1-1994 & G.O.Ms.No. 41 Dt. 11-5-2006 and other orders issued by the Government time to time. Which are not specified in this proceeding shall be completed with.
26. The Correspondent is informed that the Institution as founded /Permitted by Department as per chapter(1) Section 2 of RTI Act 2005.The management should abide the rules of RTI Act 2005.
27. The Management should submit building structural soundness certificate from competent authority every year without fail

The Correspondent is requested to submit compliance report on fulfillment of conditions prescribed, within three months through Inspecting officer concerned without fail. The receipt of the proceedings shall be acknowledged.
